under

1. That the name of the Trust shall be

2. That the registered office of the

3. That the subjects of the Trust shall be wholly for public and charitable purpose and its income shall be applied for accumulated in India wholly for public and charitable purpose without prejudice to the generally of provisions aforesaid and the following shall be deemed to be the **principal objects** :-

- a) To establish, open, conducts and run all types of vocational institutes and educational institutes including nursery, primary, pre nursery, preparatory, higher secondary and the upper higher secondary educational institutions/ schools and colleges by seeking recognition and affiliation from the concerned Departments.
- b) To conduct coaching classes for the preparation of the various competitive examinations including typing, shorthand, computer education, tailoring, doll making, embroidery, puppet making, carpet making, toy making, handicrafts, ITI., Engineering,

management, computer trades,
accountancy, motor driving, electrical,
leather works, carpentry, primary
health care, etc.

- c) To arrange and organize get together picnics, celebrations of festivals and other functions for the social advancement.
- d) To publish books, charts, illustrations, journals, magazines and other publications for the advancement of the Trust.
- e) To provide food, clothes, shelter and other required facilities to the people who have faced the Natural calamities like droughts, floods, fire, cyclones, earth quake, accident, etc..
- f) To open, found, establish, promote, set up and run community homes, marriage homes, night shelters, old age homes, orphans, lunatic asylums, medical and charitable dispensaries, hospitals, nursing homes, etc.. for the use of general public and for the welfare of the general public.

- g) To encourage games, sports, yoga, judo, hockey, football, cricket and other games for the improvement of health amongst the youth and children.
- h) To asset and cooperate and work with other associations, trusts, society, NGOs whose aims and objects are in consonance with the aims and objects.
- i) To collect information, notices, notifications policies from the Govt. and NGOs and provide the same to the general public.
- j) To receive financial and non financial assist , grant in aid, from Govt. Non Governmental organizations, mother NGOs etc.
- k) To purchase and acquire the land for the fulfillment of the objects of the Trust.
- l) To invest its money and funds according to Section 11(5) of the I.T. Act 1961.
- m) To provide coaching to the needy and children.
- n) To promote the education in all and every manner.

- d) To invest trust funds or properties whether representing the corpus or income in such investment as the settlor shall think fit and proper and to keep invested the same either in the purchase moveable and immoveable properties.
- e) To borrow or raise funds.
- f) To adjust settle, compromise, refer to arbitration all actions, suits, claims, demands and proceedings, regarding the Trust funds or any matter arising in connection with the management of the Trust.
- g) To appoint lawyers, pleaders, Advocates to file and defend the suits filed and against the Trust.
- h) That the settler of the Trust shall be entitled to reimburses themselves from the Trust properties and Trust fund for any expenses actually incurred by them in course of carrying out the objects of the Trust.

p) And generally to do all such other acts for the welfare of Trust.

4. **THE SETTLOR/FOUNDER shall have the following Powers and Duties :-**

- a) To accept donations, contributions, grants, subscriptions for and on behalf of the Trust.
- b) To manage the properties and other assets for the Trust for the title being and to do all such other acts necessary for the preservation, maintenance, and management of the Trust and the properties.
- c) From time to time very investments, representing the assets of the Trust including properties; and any party thereof and the income of the same as the settler may think fit and proper with full powers and liberty to sell or otherwise deal with the moveable and immoveable properties

- i) the settler /or a resolution of the majority will be at liberty to appoint any Trustee or Trustees to discharge any of the Trustee if shall require 2/3rd majority.
- j) The Settlor may delegate in writing all or any of his power under these presents to his/her co-trustees or nominees(S) who will be entitled to exercise such power or powers in the same manner as the Trustee himself could have done personally.

POWERS and Duties of the Trustee(s)

He/she will work as the direction of the Settlor and he /she will also help, assist him in his/her work. In the absence of the Settlor. He/she will use and enjoy all powers and duties which are entrusted to the Settlor.

Deed of Delegation

when such of the Trustee or such other person who has been so appointed by the majority or the Trustee to do such act or acts or anything in pursuance or such powers given to him for then like issuing receipt of the final payments so received , executing deeds or immoveable properties for transfer doing such other act or acts as shall be deemed to have been done by the Trustees jointly and the persons with whom such transactions deed or documents, receipt or instrument are execute shall be immune from their liability.

That for the purpose of meeting 2/3rd trustees and/or half of the number of the trustees present, if the total number of the Trustees more than three 50 % will from the quorum of the meeting. In the advent of difference of opinion and the meeting or in any other

case, the opinion of the managing Trustee if appointed shall prevail in the event of votes being equal the Settler of meeting shall have casting of votes in case of tie.

5. That Trustee may be decide any matter by circulation without meeting being held but resolution can only be passed by circulation without meeting is held if it is evident in writing under the hands $\frac{2}{3}$ rd of trustees of Trust and must be passed by the Trustees in the next meeting held.

6. That yearly account of the Trust shall be audited upto 31st March each year and the accounts shall be audited by a chartered Accountant appointed by the Settlor for the said period. Fees if paid shall be outgoing of the income and expenditure of the Trust.

8. That managing Trustee or Trustees may at any time make such amendments, draw up such schemes and make and or frame such rule as he shall in his discretion think fit for the administration of the property for the time being in held by the Trust subject ton the provisions of this Deed may at any time demand, later, or any of the amendments and any scheme bye-laws or rules as they shall think fit.

9. That Trust hereon created would be absolute and irrevocable.

10. That Trustees may in to decide unanimously dissolve the Trust and transfer the Trust and such part or parts thereof remaining in the hand of the Trustee representing the same upon the

Government or institution with similar objects as of this Trust, out not part of the Trust fund shall be transferred to the settler at any time under any conditions upon dissolution.

11. That the other acts or deeds then enumerated herein hereto shall be governed by this Indian Trust Act.

12. That in case of difference of opinion between the settler and the Trustee in any matter concerning this Trust or the management of its property which any hereinafter be acquired bequeathed or the execution of the Trust hereby the opinion of the majority of the Trustees shall prevail.


